



CONSUMER AFFAIRS COMMITTEE:

Monitors the social conscience and performance of companies in order to provide safe and honest products & services. It also is responsible for educating members on issues like truth in lending, truth in advertising, and consumer fraud. Here are some helpful resources for your investigation.

TOOLS FOR MONITORING COMPANIES

Make sure you gather your information from dependable sources. These include: government websites, public filings, and reputable news sources. Remember, when doing research, always check the source and the date!

► FINANCIAL FILINGS

U.S. Securities and Exchange Commission

Companies that are traded on one of the U.S. stock exchanges are required to disclose information on a regular basis to the Securities and Exchange Commission (SEC). You can find these documents on a publicly traded company's website or directly from the SEC. Start with the Form 10-K (Annual Report) and the DEF 14A (Proxy Statement). The 10-K covers a wide variety of information on the operation of the firm, its properties, any pending or potential legal proceedings, and a wealth of financial information. The DEF 14A includes, among other things: information on directors, director compensation, executive compensation, termination benefits (aka Golden Parachutes), and "perks".

► HEALTH AND SAFETY

Occupational Safety and Health Administration

Here you can search for violations by individual employers. You can also search for violations by SIC code, background on regulations, statistics and trends, and more.
